



NEW ELEMENTARY [Kindergarten- 6th Grade]

□ **Physical Evaluation**: Physical exam must include an examination by a primary care provider and student's medical history. Physical examination dated within 12 months prior to school entry required. [Pacific Union Conference- Ed. Code A23-116]

□ **Dental Exam** [TK, Kindergarten, 1st Graders]: Assessment dated within 12 months prior to his or her first year of school, will meet the health requirements. An oral health assessment by a licensed dentist or other licensed/registered dental health professional is requested of students entering into Transitional Kindergarten, Kindergarten, or First Grade for the first time. [Southeastern California Conference Office- Education Red Book]

□ **Immunization Record**: Provide La Sierra Academy with student's immunization history or a copy of their school health record. The California School Immunization Law requires that children be up to date on their immunization (shots) to attend school. A personal beliefs exemption is no longer an option for entry into school. [California Department of Public Health]

If your student needs a temporary or permanent medical exemption, letters are no longer being accepted. Families are required to request a medical exemption from CAIR-ME http://cair.cphd.ca.gov/exemtions/home [California Department of Health]

□ **Medication Consent Form**: If medication for your student will need to be administered during school hours, an *Administration of Medication by School Personnel Consent* form or *Self-Administration Consent* form must be completed. <u>*Primary care provider*</u> signature is required (even for over the counter medications). NEW JUNIOR HIGH [7th and 8th grade]

□ **Physical Evaluation**: Physical exam must include an examination by a primary care provider and student's medical history. Physical examination dated within 12 months prior to school entry required. [Pacific Union Conference- Ed. Code A23-116]

7th grade applicant's physical examination must include a *scoliosis exam*.

□ **Sports Physical Exam:** Students looking to participate on a La Sierra Academy athletic team must receive an annual physical examination conducted by a primary care provider certifying that the student is physically fit to participate in athletics. The physical examination must be completed within 12 months **prior** to tryouts of selected sport of interest, practice or participate in interscholastic athletic competition. (pg. 2 & 3 of LSA's Physical Form) [CIF SS- Blue Book]

NEW HIGH SCHOOL [9th-12th Grade]

□ **Sports Physical Exam:** Students looking to participate on a La Sierra Academy athletic team must receive an annual physical examination conducted by a primary care provider certifying that the student is physically fit to participate in athletics.
